- Late delivered bid security will lead to mark bid as non-responsive. Scanned copy of bid security shall be attached with bid to be uploaded on EPADS.
- All bids must be submitted electronically through the E-PADS system; no alternative submission methods will be accepted.
- The bids submitted via E-PADS will be opened in office of **National Seed Development and Regulatory Authority (NSDRA), Plot No 25, Street 6, Sector H-9/1 Islamabad** in the presence

of the Procurement Committee and authorized representatives of participating firms who wish to attend.

- All other terms and conditions are given in the bidding documents. However, interested Bidders can obtain any further information/clarification from the office of National Seed Development and Regulatory Authority (NSDRA), Plot No 25, Street 6, Sector H-9/1 Islamabad.
- In case of any unforeseen situation resulting in closure of office on the date of opening or if the Government declares Holiday the tenders shall be submitted / opened on the next working day at the same time & venue.
- Any conditional or un-accompanied of the bid security, tender will not be considered in the competition.
